### **ORDER :**

In the Government Order first read above, the Government have framed the Tamil Nadu Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015 and the Tamil Nadu Street Vendors (Protection of Livelihood and Regulation of Street Vending and Licensing) Scheme, 2015 under the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014).

2. In the Government Order second read above, the Commissioner, Greater Chennai Corporation was permitted to constitute 15 Town Vending Committees one each at Zonal level in Greater Chennai Corporation as per rule 11 of the Tamil Nadu Street Vendors (Protection

of Livelihood and Regulation of Street Vending) Rules, 2015 with Zonal Executive Engineer as the Chairperson.

3. The Government Order second read above was struck down by the Hon'ble High Court of Madras in its order dated 27.04.2022 in W.P.No.6799 of 2022 on the ground that the said Committee did not include the Municipal Commissioner as the Chairperson and hence it is in conflict with section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014). However, the Hon'ble High Court granted liberty to constitute a Town Vending Committee as per the provisions of law. Accordingly, in the Government order third read above, the Government, constituted the Town Vending Committee for the Greater Chennai Corporation under section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014) with the Commissioner, Greater Chennai Corporation as the Chairperson.

4. Further, based on the orders of the Hon'ble High Court of Madras, dated 25.02.2025 and 02.04.2025 in W.P.No.14977, 14980, 15959, 16061, 16485, 16488, 16489 and 16491 of 2024, filed by P.Hemaganesh and 7 others, the Government has superseded the Government Order third read above and permitted the Commissioner, Greater Chennai Corporation to constitute one Town Vending Committee in each of the 15 zones, as per the following composition with each Committee headed by the respective Regional Deputy Commissioner in the Government Order fourth read above:

Further, the Commissioner, Greater Chennai Corporation was requested to pursue necessary action in terms of rule 11 (3), 12 and 13 of the Tamil Nadu Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015 and section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014) and send necessary proposal to Government, at the earliest in the Government Order fourth read above.

5. The Commissioner, Greater Chennai Corporation in the reference fifth read above stated that as directed by the Government, in accordance with Rule 11 (3), 12 and 13 of the Tamil Nadu Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015, the Greater Chennai Corporation has passed a Council Resolution No.641/2025, dated 28.05.2025 to constitute Zone-wise Town Vending Committees for conduct of election for the 6 representatives from among the street vendors. The election for electing six street vendors for each zone conducted on 26.06.2025 in a free and peaceful manner. Subsequently, the Town vending Committee for each zone under the Chairperson of Regional Deputy Commissioner concerned consisting of 14 members including 6 representatives from among the street vendors were elected through election. Further, four persons for each Zone of the Town Vending Committee viz., one Representative of Traders Association, two Representatives of Non-Governmental and Community based Organizations and one Representative of Resident Welfare Association recommended by the Regional Deputy Commissioners concerned. They have been nominated as members of the Town Vending Committee of the concerned Zone.

6. The Commissioner, Greater Chennai Corporation has also stated that based on the details received from the Commissioner of Police, Greater Chennai, Avadi and Tambaram specifying the relevant Range of the Assistant Commissioner of Police (Law and Order) and Assistant Commissioner of Police (Traffic) for each zone included as members of the Town Vending Committee of the concerned zone.

7. The Commissioner, Greater Chennai Corporation has therefore requested the Government to issue orders for constitution of one Town Vending Committee for each of the 15 zones headed by the Regional Deputy Commissioners of the North, Central and South Zones.

8. The Government, after careful examination of the proposal of the Commissioner, Greater Chennai Corporation has decided to constitute the Town Vending Committees for the Greater Chennai Corporation under section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014). Accordingly, the appended notification will be published in the Tamil Nadu Government Gazette, extraordinary, dated 07.10.2025.

9. Further, the Commissioner, Greater Chennai Corporation is requested to take necessary action to notify the constitution of the Town Vending Committee along with the names of all members in a prominent place in the office of the Regional Deputy Commissioners of the North,

Central and South Zones, as required under rule 14 of the Tamil Nadu Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015.
